

**TERMS AND CONDITIONS**  
**SUPER STARS & SUPER CARS 3 PROMOTION**

**Conditions of Entry**

1. Information on how to enter and the prizes form part of these Terms and Conditions. Entry into this competition is deemed acceptance of these Terms and Conditions.
2. Employees (and their immediate families), their retailers, suppliers, associated companies and agencies associated with this competition are ineligible to enter.
